## CLAUSES

The host declares to take care of the animal solely and exclusively as a companion animal. To this end, I undertake to fully comply with each and every one of the following obligations, having been informed that the continuity of the foster transfer of the animal will always be conditional on its effective compliance:

1. The host is responsible for the animal during the time that it remains in their custody with respect to the damages that it could suffer or cause, having to guard it and comply with the current regulations that concern it.
2. The dog will have a chip in the name of the association that owns it until its adoption is formalized.
3. To provide the animal with the necessary assistance at all times, taking into account its state of health, maintaining under this contract the commitment to give it adequate treatment, not to keep it permanently tied up or subject it to any other improper

treatment or contrary to the provisions of the current animal protection law, giving it a familiar treatment.

4. For your veterinary care, if you need any unforeseen or prescribed treatment, you must inform the association in advance who will authorize it. For this purpose, the association offers a series of collaborating veterinary clinics.

5. Fostering is determined for an agreed period of time of: \_\_\_\_\_, or for an indefinite period, and may end at the will of the host.

6. To assume their food, considering that with their reception there is a will to help the entity. The host can assume other expenses of the animal, if he wishes, otherwise they will be borne by the association.

7. To allow the inspections carried out by the volunteer in charge of Nature and Animals, which is reserved and expressly accepted by the host, the recovery of the animal without any consideration if, in the opinion of the Board of Directors of this Association, The animal was not maintained in the proper conditions of treatment and habitat, or if the host did not comply with the obligations indicated in this document.

8. To agree to teach the dog when an adoption opportunity arises.

9. The host informs about his/her housing situation according to: \_\_\_\_\_.

10. End the foster care whenever you want without committing yourself.

The Association undertakes to:

- To deliver the dog identified with a microchip.
- To assume the veterinary expenses, unless the foster is offered.
